This building was constructed through the Supportive Housing Loan Program (SHLP), of the New York City Department of Housing Preservation and Development. Supportive housing is permanent, affordable housing with on-site support services to serve the needs of the most vulnerable New Yorkers, including the formerly homeless and disabled. Sixty percent of units in supportive housing are set aside for low income or formerly homeless individuals or families with special needs, who are referred by city agencies. The remaining forty percent of units in the building are made available to the public through lottery. The units listed in this notice are only those made available to the general public This building was also constructed through Voluntary Inclusionary Zoning, and Affordable Independent Residences for Seniors (AIRS) of the New York City Department of Housing Preservation and Development.

Who Should Apply?

Individuals or households who meet the income and household size requirements listed in the table below may apply. At least one (1) household member must be age 62 or older. Qualified applicants will be required to meet additional selection criteria. Applicants who live in New York City receive a general preference for apartments.

- A percentage of units is set aside for:
 - Mobility–disabled applicants (5%)
 - Vision/Hearing–disabled applicants (2%)
